



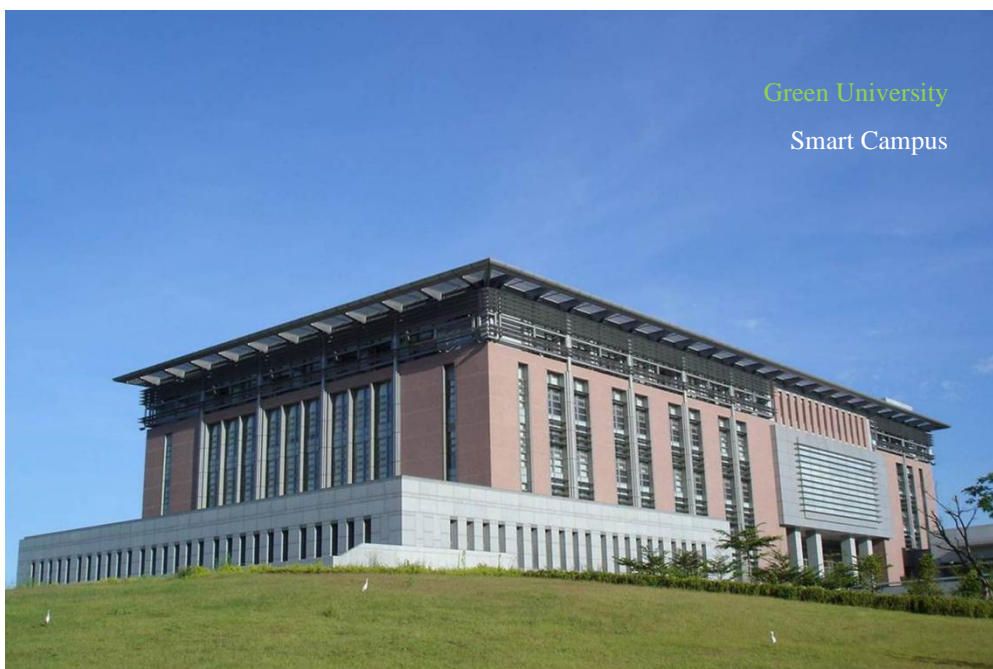

Admission Prospectus 2026 for International Foundation Program

壹、申請條件/ Admission Requirements:

一、申請人資格/Applicant Eligibility:

須符合下列身份資格之一者，始具備外國學生申請入學之資格：

A person of foreign nationality who has never held Republic of China ("R.O.C.") nationality and who meets the following requirements is permitted to apply for admission to an educational institution, in accordance with the provisions of these Regulations:

(一) 具外國國籍且未曾具有中華民國國籍(註 1)，符合下列規定者，得依本辦法申請入學：

1. 未曾以僑生身分在臺就學。
2. 未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。

I. The person has never undertaken studies in Taiwan as an overseas Chinese student.

II. The person has not been given a placement in the current academic year by the University Entrance Committee for Overseas Chinese Students in accordance with the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan.

(二) 具外國國籍並符合下列規定，且最近連續居留海外(註 2)六年(註 3)以上者，亦得依本辦法申請入學：

1. 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

2. 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

3. 前二款均應符合前項第一款及第二款規定。

I. Students with foreign nationalities and meet the following requirements have recently stayed overseas (Note 2) for more than six years (Note 3), their application must comply with the Ministry of Education's "Regulations for International Students to Study in Taiwan".

II. An individual who has nationality status from the ROC at the time of his/her birth but does not hold residence registration must state this on his/her college application.

III. An individual who had had nationality status from the ROC but has no ROC nationality at the time of his/her application must have had an annulled status regarding his/her ROC nationality for less than 8 years after an annulment of his/her ROC nationality by the Ministry of the Interior Affairs.

(三) 具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年(註3)以上者。

An applicant has foreign nationality, and holds a permanent residence status in Hong Kong or Macao, but has no history of a residence registration record in Taiwan, who, at the time of application has resided in Hong Kong, Macao, or another foreign country for no less than 6 years, is qualified to apply for admission under these regulations.

(四) 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年(註3)以上者。

An applicant of foreign nationality who has been a former citizen of Mainland China and has no history of household registration record in Taiwan, and at the time of application, has resided overseas continuously for no less than 6 years, is qualified to apply for admission under these regulations.

※註1:依「國籍法第二條」規定，有下列各款情形之一者，屬中華民國國籍：

※Note 1: The aforementioned ROC nationality is defined in accordance with Article 2 of the Nationality Act. Any individual who meets one of the following conditions shall be considered to hold ROC nationality:

- a. 出生時父或母為中華民國國民。
- b. 出生於父或母死亡後，其父或母死亡時為中華民國國民。
- c. 出生於中華民國領域內，父母均無可考，或均無國籍者。
- d. 歸化者。

以上第一款及第二款之規定，於國籍法修正公布時之未成年人，亦適用之。

i. At birth, the individual's father or mother was a citizen of the ROC.

ii. An individual who was born after the death of his/her father or mother who was a citizen of the ROC.

iii. An individual was born in the ROC though his/her parents were unknown or no nationality.

iv. A naturalized ROC citizen.

Preceding Subparagraph 1 and Subparagraph 2 shall also apply to the persons who were minors at the time of the amendment and promulgation of this Act.

※註2:本項所稱「連續居留」，指外國學生每曆年在國內停留期間未逾一百二十日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在本國內停留期間未逾一百二十日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在本國內停留期間，不併入海外居留期間計算：

a. 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。

b. 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。

c. 交換學生，其交換期間合計未滿二年。

d. 經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

※Note 2: The term “reside overseas continuously” means that an individual may stay in Taiwan for no more than 120 days per calendar year. If the period of calculated calendar year is not one complete year, their stay in Taiwan should not exceed 120 days within the calculated calendar year.

※註3: 所列「六年」，係以擬入學當學期起始日期（二月一日或八月一日）為終日計算之；所稱「海外」，指大陸地區、香港及澳門以外之國家或地區。

※Note 3: The period of six year is calculated based on the starting date of the semester (February 1 or August 1). The term “overseas” is prescribed to countries or regions other than Mainland China, Hong Kong and Macao.

二、學歷資格/Requirements to apply:

(一) 符合我國教育部採認之高中畢業：申請學士班者需具國外高中畢業學歷。

I. To apply, a high school diploma is required. Diplomas must be issued by schools recognized by the R.O.C. Ministry of Education.

(二) 具有與我國學制相當之同等學力資格者。

II. If no diploma, applicants must hold equivalent qualifications for undergraduate or graduate study.

A person referred to in either of the preceding two subparagraphs shall meet the requirements stipulated in Subparagraph 1 and Subparagraph 2 of the previous paragraph.

三、其他應符合之規定/Other requirements :

(一) 欲申請就讀學士班者，須未曾在我國以外國學生身分申請並完成高中學校學程。

I. Applicants who have completed secondary education in the Republic of China are not eligible to apply to bachelor degree programs as foreign students.

(二) 須未曾遭入學學校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者。

II. International students who are expelled from any university/college after admission due to any misconduct, poor academic performance or a conviction under the Criminal Code may not thereafter reapply.

(三) 須未曾因違反本校校規情節重大而遭本校註銷選讀資格者。

III. Applicants who have been previously disqualified from participating in National University of Kaohsiung courses as a result of any violation of university regulations are ineligible to apply.

(四) 須符合招生簡章各系所個別要求之申請條件。

IV. Applicants must meet all individual departmental requirements.

註：有關身分及學歷驗證，由僑委會、教育部及本校依相關法規辦理。

申請人皆須填寫「國際專修部入學切結書」(附表一, P16)。另，為利本校審查僑生/港澳生身分及學歷資格規定，請僑生、港澳生身份的考生務必填具「身分及學歷資格聲明書(切結書)」(附表二, P17)及「僑港澳生身份查核入學申請表」(附表四, P.19)；港澳生須另加填「港澳生報名資格確認書」(如附表三, P.18)。

Affidavit for Admission Program (Attachment 1) is required to be signed by the applicant. In addition, overseas Chinese/ Hong Kong/ Macau applicants have to sign on the Identity and Academic Qualification Affidavit (Attachment 2) & Application Form (Attachment 4) to confirm the identity. Other than the above documents, Hong Kong, Macau Students is required to sign on the Confirmation Letter of Eligibility for Hong Kong, Macau (Attachment 3).

貳、修業年限及入學時間/ Duration of Study & Semester to Enroll :

一、華語先修期：華語先修期最長以 1 年為限，期滿前須通過華語文能力測驗 (TOCFL) 之聽力與閱讀測驗基礎級 (A2)，測驗結果達 A2 標準者得進入學系修讀專業課程。

(1) Chinese Learning Program: 1 year. Students are required to achieve Level 2 (A2) listening and reading of the Test of Chinese as a Foreign Language (TOCFL) during the period.

二、學士班：以 4 年為原則，但得視學系性質延長 1 年至 2 年。(註：建築學系修業年限為 5 年)

(2) Bachelor's Program: Usually in a period of 4 years. Students may postpone graduation for 1-2 years to meet the departments' requirement. (*The required duration of study of the Dept. of Architecture is 5 years.)

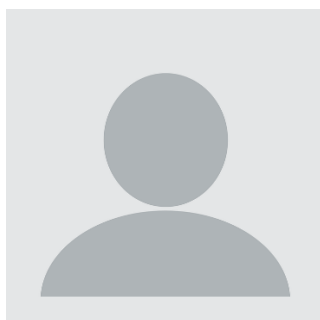

The diploma I provided is recognized by the Ministry of Education and verified by a Taiwanese overseas embassy. Upon registration, a photocopy of the certificate of diploma obtained from a foreign educational institution and verified by a Taiwanese overseas embassy shall be submitted with a notarized translation in either Chinese or English.

Students who fail to pass the TOCFL are subject to withdrawal from the school and will be notified of the cancellation of their residence status. They must depart before the residence permit expires.

During the period of study, if I apply for withdrawal, renounce my student status, lose contact, transfer to another school, or withdraw from the program midway for any other abnormal or personal reasons, resulting in the university being required to return the related subsidy funds, I agree to personally bear and reimburse the university the subsidy amount of New Taiwan Dollars Thirty Thousand (NTD 30,000), and I am willing to comply with all relevant regulations of the university and the Ministry of Education.

The international students who work without a valid work permit will be fined between NTD 30,000 and NTD 150,000. They will immediately be ordered to leave Taiwan and will not be permitted to work in Taiwan in the future. If they fail to depart within the specified period, the Ministry of the Interior National Immigration Agency may enforce their departure or hold them in detention until they are deported. (See Paragraphs 1, 3 and 4 of Article 68 of the Employment Service Act.)
